The personal data that we process

Dutch IT Channel B.V. processes your personal data when you use our services and/or when you provide us with such data yourself.

We process the following personal data:

- Company name First and last name
- Gender
- Address details
- Telephone number
- E-mail address
- IP address
- Other personal data that you actively provide, such as by creating a profile on these websites, in correspondence, and by telephone
- Information about your company and activities (only for partners in business)
- Internet browser and device type
- Bank account number (only for Partners in Business)

Special categories of personal data and/or sensitive personal data we process. Our website and/or services do not have the intention to collect data about website visitors under the age of 16 unless they have consent from their parents/guardians. However, we are unable to check whether visitors are over 16 years old. We therefore recommend that parents/guardians supervise their children's online activity to prevent their children's data from being collected without the consent of parents/guardians. The purposes for which and the basis on which we process personal data

Dutch IT Channel B.V. processes your personal data for the following purposes:

- Sending the newsletters Informing you of, or inviting you to, one of our events

- To deliver goods and services to you Customer contact (for Partners in Business) Dealing with the payment of a Partner package
- Informing and consulting you about content components of the Partner in Business package
- Being able to call or e-mail you in order to carry out our services
- Informing you about changes to our services and products

Automated decision-making

Dutch IT Channel B.V. does not make decisions based on automated processing on matters that can have consequences, minor or major, for individuals. This concerns decisions that are made by computer programs or systems without any human input by a person (e.g. an employee of Dutch IT-channel). How long we retain personal data for Dutch IT Channel B.V. does not retain your personal data for longer than is strictly

necessary in order to achieve the purposes for which your data are collected.

Sharing your personal data with third parties

Dutch IT Channel B.V. does not sell your data to third parties and only provides it if this is necessary in order to perform our agreement with you or to meet a legal obligation. We enter into a processor agreement with the companies that we share your data with, ensuring that your data is processed with the same level of security and confidentiality. Dutch IT-channel remains responsible for these processing operations. Personal data is only used for the purposes for which it was requested. Personal data will only be shared with third parties if explicit consent has been given when the data is transferred.

Cookies and similar methods that we use

Dutch IT Channel B.V. uses functional, analytical, and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet, or smartphone when you visit this website for the first time. Dutch IT-channel uses cookies with a purely technical function. These cookies are also used to ensure the website works properly and enables us to optimize it. We also place cookies that track your browsing behaviour. When you visit our website for the first time, we inform you about these cookies and ask for your consent to place them.

Change cookie preferences

Rectification or erasure of data

You have the right to rectify your personal data that we store or have this data erased. You have the right to withdraw your consent to your data being processed or to object to Dutch IT-channel, Executive-People, or Dutch Connect processing your personal data, and you have the right to have your data transferred to another organization (data portability). This means that you can submit a request to us to send the personal data that we have in your computer file to you or to another organization that you specify.

You can send a request to rectify or erase your personal data, or to withdraw your consent or object to the processing of your personal data, to rdekleijnen@dutchitchannel.nl.

To be sure that you are the person who has requested access, we ask you to send a copy of your ID with the request. On this copy, please black out your passport photo, the MRZ (machine readable zone, the strip with numbers at the bottom of the passport), your passport number, and, if applicable, your Citizen Service Number (Burgerservicenummer, BSN). This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks at the
